In compliance with 16 TAC § 26.404, I am writing to report quarterly Small and Rural Incumbent Local Exchange Carrier Universal Service ("SRILEC USP") support received by West Texas Rural Telephone Cooperative, Inc. ("WTRT").

For the second quarter reporting period, WTRT is required to provide the amounts of SRILEC USP support for the months of April, May, and June 2023. At the time of the second quarter report, WTRT did not know the actual amount that it would receive for the month of June 2023. WTRT provides this revised second quarter data as an update to include the month of June.

For this reporting period, WTRT is required to provide the amounts of SRILEC USP support for the months of July, August, and September 2023. WTRT will not know the actual amount that WTRT will receive for the month of September 2023 until Solix performs the proration as instructed by the Commission and sends the funds to the company. WTRT plans to update this report to include the month of September when filing the report that is due for the fourth quarter of 2023.

For ease of reference, WTRT is providing the monthly support amounts that the Commission has ordered the company to receive and the amounts paid by Solix for the applicable reporting period.
