# COMMISSION STAFF'S COMMENTS REGARDING THE APPLICATION AND NOTICE

NOW COMES Staff of the Public Utility Commission of Texas (Commission Staff or Staff), representing the public interest, to submit these comments regarding the Application and Notice.

On April 22, 2013, Alenco Communications, Inc. d/b/a ACI. (ACI or Applicant) filed an application for revisions to its Local Exchange Tariff to increase the monthly residential Local Exchange Access Line rates in all its exchanges. ACI is also requesting to remove the optional Extended Area Service offered to both Business and Residential customers in the Dolores, Modeana and West Marietta Exchanges and replace this offering with a mandatory Toll-Free Expanded Local Calling Scope that will allow customers to make local calls to (956-NXX) exchanges in Laredo and customers in the Donie Exchange to make local calls to exchanges in Mexia and Groesbeck. ACI is also requesting to increase the business rates in the Alexander and Carlton Exchanges for the Rotary Hunting Service to equalize rates with the Maryneal, McCaulley and Sylvester Exchanges.

Staff has reviewed the application and proposed notice. As detailed in the attached memorandum of Stephen Mendoza, of the Commission's Rate Regulation Division, Staff finds that the application is sufficient for further review and recommends that the notice be deemed sufficient pursuant to P.U.C. SUBST. R. 26.171(d).

#### RECOMMENDATION ON SUFFICIENCY

On April 22, 2013, Alenco Communications, Inc. d/b/a ACI ("ACI" or "the Company") filed a notice with the Commission to initiate a minor rate change, with its proposed tariff to be effective June 1, 2013.

#### **Background**

ACI files this notice for a minor rate change and proposes to increase the current monthly Local Exchange Access Line Rate for residential and business customers in certain exchanges consistent with the table shown at the end of this recommendation (see ATTACHMENT). ACI proposes these rate increases in an effort to meet the 2013 local rate floor established for residential access lines by the Federal Communications Commission (FCC) in its USF/ICC Transformation Order. The Transformation Order would reduce universal support to the extent that a carrier's residential rates and other regulated state fees do not meet the rate established rate of \$14.00. ACI explained that the proposed rate increases will allow the Company to continue to receive the maximum federal universal service fund, high-cost loop support for the reporting period of July 1, 2013 to June 30, 2014.

Additionally, ACI is requesting to remove the optional Extended Area Service (EAS) offered to both business and residential customers in the Dolores, Modena and West Marietta Exchanges and replacing this offering with a mandatory Toll-Free Local Calling Scope (ELCS) that will allow customers to make local calls to (956-NXX) exchanges in Laredo, and customers in the Donie Exchange to make local calls to exchanges in Mexia and Groesbeck. The ELCS is similar to what customers already have in the other exchanges served by ACI. Lastly, ACI is

proposing to increase the business rates in the Alexander and Carlton Exchanges for Rotary Hunting Service (see ATTACHMENT).

A review of the application finds that the increase in the Local Exchange Access Line rate for residential and business customers is not greater than the 50% limitation as prescribed in P.U.C. SUBST. R. 26.5(147). ACI provided information which indicates that the overall impact on the regulated intrastate gross revenues for the currently proposed rate increase results in an increase of \$36,060 or 1.42%, which is less than a 5 percent impact. Therefore, ACI's notice of a minor rate change is appropriate and consistent with the definition of a "minor change" in P.U.C. SUBST. R. 26.5(147).

#### **Notice and Waiver Requests**

In its filing, ACI stated that it would provide direct customer notice by bill insert of this proceeding on May 1, 2013, which is at least 10 days prior to the proposed effective date of ACI's proposed rate changes. In addition, the Company provided a copy of its direct customer notice. ACI appears to have satisfied the provisions of P.U.C. SUBST. R. 26.171(d) for notice requirements. The Company has not requested any good cause waivers in this filing.

#### Conclusion

The notice filed with the Commission by ACI for a minor rate change appears to be sufficient and complete.
