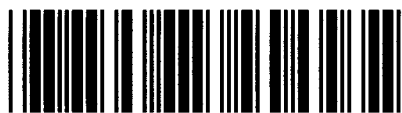

**TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS ("Commission"
or "P.U.C."):**

COMES NOW Oncor Electric Delivery Company LLC ("Oncor"), and files this list of issues pursuant to the Commission's Order of Referral in this proceeding, respectfully showing as follows:

I. Issues to be Addressed in this Proceeding

Oncor recommends that the following issues be considered in this annual energy efficiency cost recovery factor ("EECRF") adjustment proceeding:

1. Does Oncor's EECRF application comply with P.U.C. SUBST. R. 25.181(f), contain the testimony and schedules required by P.U.C. SUBST. R. 25.181(f)(10), and address the factors required by P.U.C. SUBST. R. 25.181(f)(11)?
2. Are the costs to be recovered through Oncor's EECRF reasonable estimates of the costs necessary to provide energy efficiency programs and to meet Oncor's goals in accordance with P.U.C. SUBST. R. 25.181 and PURA¹ § 39.905?

3. Are Oncor's calculations of any under or over-recovery of EECRF costs reasonable and consistent with P.U.C. SUBST. R. 25.181 and PURA § 39.905?
4. Is Oncor's proposed energy efficiency performance bonus reasonable and consistent with P.U.C. SUBST. R. 25.181 and PURA § 39.905?
5. Are Oncor's estimated expenses relating to the Commission's evaluation, measurement and verification costs reasonable and consistent with P.U.C. SUBST. R. 25.181 and PURA § 39.905?
6. Are the costs related to municipalities' EECRF proceeding expenses reasonable and consistent with P.U.C. SUBST. R. 25.181?
7. Are Oncor's assignments or allocations of its proposed 2014 EECRF rates to rate classes reasonable and consistent with P.U.C. SUBST. R. 25.181 and PURA § 39.905?
8. Is Oncor's estimate of billing determinants for its proposed 2014 EECRF reasonable and consistent with P.U.C. SUBST. R. 25.181?
9. Has Oncor properly calculated its proposed 2014 EECRF rates in accordance with P.U.C. SUBST. R. 25.181?
10. Does Oncor's proposed tariff schedule comply with P.U.C. SUBST. R. 25.181?
11. Are the energy efficiency costs recovered by Oncor for all prior program years reasonable and in compliance with P.U.C. SUBST. R. 25.181 and PURA § 39.905?
12. Do Oncor's proposed EECRF rates comply with the requirements of P.U.C. SUBST. R. 25.181(f)(7)?

13. Do Oncor's proposed EECRF rates comply with requirements of P.U.C. SUBST. R. 25.181(r) regarding the targeted low-income energy efficiency program?

The foregoing issues are consistent with P.U.C. SUBST. R. 25.181 and PURA § 39.905. Oncor respectfully reserves the right to raise other relevant issues during the course of this proceeding, or to respond during the course of this proceeding to those issues raised by other parties or the Commission.

II. Issues Not to be Addressed in this Proceeding


