QUESTION: ARE YOU AN INTERVENOR IN SOAH DOCKET NO. 473-13-5207 AND PUC

DOCKET NO. 41606 AND ON WHOSE BEHALF ARE YOU TESTIFYING?

ANSWER: Yes.

QUESTION: HAVE YOU EVER TESTIFIED IN A PUBLIC UTILITY COMMISSION OF

TEXAS ("PUC" OR "COMMISSION")PROCEEDING?

ANSWER: No, we have not.

QUESTION: BRIEFLY DESCRIBE YOUR OCCUPATION EDUCATIONAL AND WORK

HISTORIES.

ANSWER: Supervisor of farm labor workers since 1962.

QUESTION: WHERE IS YOUR PROPERTY LOCATED?

ANSWER: Our property is located along Highway 509 near Hudson Road in Cameron County.

The legal description is San Benito Land and Water Company Blk 155, SW Acres.

QUESTION: HOW LONG HAVE YOU OWNED THE PROPERTY?

ANSWER: 1985 to present.

QUESTION: ARE YOU FAMILIAR WITH THIS AREA OF SOUTH TEXAS?

ANSWER: Yes, we were raised in the Valley and lived in the Valley most of our adult lives.

II. PURPOSE AND SCOPE OF TESTIMONY

QUESTION: WHAT IS THE PURPOSE AND SCOPE OF YOUR TESTIMONY?

ANSWER: The purpose of my testimony is to (a) describe our property, (b) describe the impact

of the proposed transmission line on our property, and (c) voice my opposition to

certain links and routes.

QUESTION: IS THE INFORMATION CONTAINED IN YOUR TESTIMONY TRUE AND

CORRECT AND BASED UPON YOUR KNOWLEDGE.

ANSWER: Yes

III. <u>DESCRIPTION OF PROPERTY AND THE LINE'S IMPACT</u>

QUESTION: ARE THERE ANY HABITABLE STRUCTURES ON THE PROPERTY?

ANSWER: No.

ANSWER:

It is farmland.

QUESTION: PLEASE DESCRIBE YOUR PROPERTY'S CURRENT USES, INCLUDING

BRIEFLY DESCRIBING ANY RANCH OPERATIONS.

ANSWER: The acreage is being farmed with various crops.

OUESTION: WOULD THE LINKS THAT MIGHT IMPACT YOUR PROPERTY RUN ALONG

ANY BOUNDARY LINES OF YOUR PROPERTY?

ANSWER: Yes, Link 259 and 260 would cut through the property along Hwy 509.

OUESTION: HOW WOULD A 345 KV ELECTRIC TRANSMISSION LINE IMPACT YOUR

PROPERTY AND ITS OPERATIONS?

ANSWER: The property will be practically unusable as either farmland or future development

after the construction of such a transmission line. The line would hamper aerial

spraying for raising crops and reduce property values.

OUESTION: WOULD YOU HAVE TO REGULARLY DRIVE UNDER THE TRANSMISSION

LINE IF INSTALLED ON YOUR PROPERTY?

ANSWER: Yes.

OUESTION: IS THERE ANYTHING ELSE YOU WOULD LIKE THE ADMINISTRATIVE

LAW JUDGE AND THE PUBLIC UTILITY COMMISSION TO CONSIDER IN

THIS PROCEEDING?

ANSWER: Links 259 and 260 are too close to the heavily populated areas of Harlingen and San

Benito and in particular to Harlingen's hospitals and growing medical center.

QUESTION: HOW WOULD YOU SUMMARIZE YOUR POSITION IN THIS PROCEEDING?

ANSWER: We oppose ETT/SHARYLAND's Links 259 and 260.

QUESTION: HOW WOULD YOU SUMMARIZE YOUR POSITION IN THIS PROCEEDING

REGARDING ETT/SHARYLAND'S RECOMMENDED ROUTE 32 AND THE

PROPOSED ALTERNATIVE ROUTES?

ANSWER: There is no route on our properties that would not significantly degrade its overall

value to the community. We oppose any route going west from the North Edinburg Substation, including 32. We Support the "Rhodes Alliance Route" or a "Modified Supplemental Alternative Route 3S" going east from the North Edinburg Substation, although we would prefer a Route that would avoid Link 308. Alternative Route 3S includes the following links which we do not oppose and can support: 219, 226, 233, 235, 256, 258, 265, 286, 285, 272, 269, 268, 267, 273, 308, 321, 322, 327, 328, 335,

340, 341.

QUESTION: DOES THIS CONCLUDE YOUR TESTIMONY?

ANSWER: Yes.


