Intervenors, THOMAS E. and MARTHA McLEMORE file this Direct Testimony, which

is attached. THOMAS E. and MARTHA McLEMORE stipulate that this Direct Testimony can

be treated by all parties as if the answers were filed under oath.

1. INTRODUCTION

QUESTION: PLEASE STATE YOUR NAME AND CURRENT ADDRESS FOR THE RECORD

- ANSWER: Thomas E. and Martha McLemore 16268 Jimenez Road San Benito, Texas 78586
- QUESTION: ARE YOU AN INTERVENOR IN SOAH DOCKET NO. 473-13-5207 AND PUC DOCKET NO. 41606 AND ON WHOSE BEHALF ARE YOU TESTIFYING?
- ANSWER: Yes, we are testifying for us and our family's behalf.
- QUESTION: HAVE YOU EVER TESTIFIED IN A PUBLIC UTILITY COMMISSION OF TEXAS ("PUC" OR "COMMISSION")PROCEEDING?

ANSWER: No, we have not.

QUESTION: BRIEFLY DESCRIBE YOUR OCCUPATION EDUCATIONAL AND WORK HISTORIES.

ANSWER: Project Manager at Harlingen Irrigation District, farmer in Harlingen, graduated high school and trained in electronics in the Navy prior to beginning farming. Raise hay and livestock on present location.

QUESTION: WHERE IS YOUR PROPERTY LOCATED?

- ANSWER: The property is on Jimenez Road and has a legal description of Joahn A. Hill, Part Blk 26 and 27.
- QUESTION: HOW LONG HAVE YOU OWNED THE PROPERTY?
- ANSWER: Less than one year.
- QUESTION: ARE YOU FAMILIAR WITH THIS AREA OF SOUTH TEXAS?
- ANSWER: Yes, we were raised in the Valley, raised our families here and farmed this area. We have deep family farming roots.

II. PURPOSE AND SCOPE OF TESTIMONY

- QUESTION: WHAT IS THE PURPOSE AND SCOPE OF YOUR TESTIMONY?
- ANSWER: The purpose of my testimony is to (a) describe our property, (b) describe the impact of the proposed transmission line on our property, (c) voice our opposition to certain links and routes.

III. DESCRIPTION OF PROPERTY AND THE LINE'S IMPACT

QUESTION: ARE THERE ANY HABITABLE STRUCTURES ON THE PROPERTY?

- ANSWER: Yes 1 house 2 workshop buildings
- QUESTION: PLEASE DESCRIBE YOUR PROPERTY'S TERRAIN AND ITS ECOLOGICAL OR BIOLOGICAL FEATURES.
- ANSWER: The property has many different varieties of mature trees and wildlife including owls, chachalacas, rabbits, hummingbirds and other bird species and is also used for the production of hay and livestock.
- QUESTION: PLEASE DESCRIBE YOUR PROPERTY'S CURRENT USES, INCLUDING BRIEFLY DESCRIBING ANY RANCH OPERATIONS.
- ANSWER: The property is being developed as a bed and breakfast. The area is widely known throughout the United States for its birding and many out door recreational opportunities. Our site is perfect for hosting the many eco-tourists and special events for which people would like to use nature as a backdrop. We also produce quality hay for the horse market and livestock.
- QUESTION: WOULD THE LINKS THAT MIGHT IMPACT YOUR PROPERTY RUN ALONG ANY BOUNDARY LINES OF YOUR PROPERTY?
- ANSWER: Yes.
- QUESTION: HOW WOULD A 345 KV ELECTRIC TRANSMISSION LINE IMPACT YOUR PROPERTY AND ITS OPERATIONS?
- ANSWER: It would absolutely ruin the use of our property as a bed and breakfast and ecotourism destination. We have made a lifetime investment in the property.
- QUESTION: WOULD YOU HAVE TO REGULARLY DRIVE UNDER THE TRANSMISSION LINE IF INSTALLED ON YOUR PROPERTY?
- ANSWER: Yes, to access the property.
- QUESTION: IF THE TRANSMISSION LINE IS BUILT ON YOUR PROPERTY, DO YOU HAVE ANY OTHER CONCERNS?

- ANSWER: We would be concerned about our safety and health since this is our primary residence.
- QUESTION: IS THERE ANYTHING ELSE YOU WOULD LIKE THE ADMINISTRATIVE LAW JUDGE AND THE PUBLIC UTILITY COMMISSION TO CONSIDER IN THIS PROCEEDING?
- ANSWER: Link <u>244</u> is too close to the heavily populated areas of the City of Harlingen and especially its medical centers and hospitals.
- QUESTION: HOW WOULD YOU SUMMARIZE YOUR POSITION IN THIS PROCEEDING?
- ANSWER: We oppose ETT/SHARYLAND's proposed routes using Link 244.
- QUESTION: HOW WOULD YOU SUMMARIZE YOUR POSITION IN THIS PROCEEDING REGARDING ETT/SHARYLAND'S RECOMMENDED ROUTE 32 AND THE PROPOSED ALTERNATIVE ROUTES?
- ANSWER: There is no route on our properties that would not significantly degrade its overall value to the community. We oppose any route going west from the North Edinburg Substation, including 32. We Support the "Rhodes Alliance Route" or a "Modified Supplemental Alternative Route 3S" going east from the North Edinburg Substation, although we would prefer a Route that would avoid Link 308. Alternative Route 3S includes the following links which we do not oppose and can support: 219, 226, 233, 235, 256, 258, 265, 286, 285, 272, 269, 268, 267, 273, 308, 321, 322, 327, 328, 335, 340, 341.
- QUESTION: DOES THIS CONCLUDE YOUR TESTIMONY?
- ANSWER: Yes.
