INTRODUCTION

Q. WHAT IS YOUR NAME AND WORK ADDRESS?

A. My name is Edward Wylie. My employment address is 118 S. Cage, Pharr, Texas 78577.

Q. IN WHAT CAPACITY ARE YOU EMPLOYED?

A. I am employed with the City of Pharr as the Director of Development Services

Q. HOW LONG HAVE YOU BEEN EMPLOYED WITH THE CITY OF PHARR?

A. Approximately twenty (20) years, from October 1993 to the present.

Q. WHAT ARE YOUR DUTIES WITH THE CITY OF PHARR?

A. In addition to the management of Development Services, I oversee development within the City of Pharr and its extra-territorial jurisdiction ("ETJ") including issues related to zoning, subdivision, construction, permitting, and code enforcement.

PURPOSE OF TESTIMONY

Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY?

A. I have been assigned the duties of representing Intervenors City of Pharr, Pharr Economic Development Corporation II, Pharr Tax Increment Reinvestment Zone in objecting to the proposed routes for construction and placement of the electrical transmission lines within Pharr's territory and ETJ. I have also determined a need for amendment of the proposed routes as I will describe in my testimony and the attached exhibit.

Q. HOW CAN YOUR TESTIMONY BE USED IN RELATION TO THE APPLICATION?

A. I have reviewed the proposed routes of the Applicant along with Pharr personnel. We have determined that changes are necessary to the proposed route to ensure that any construction and placement of the electrical transmission lines within Pharr's territory and ETJ does not affect current and future community and commercial needs and development.

Q. WHAT CHANGES DO THE INTERVENORS PROPOSE TO THE APPLICANT'S ROUTE?

A. The City of Pharr, Pharr Economic Development Corporation II, and Pharr Tax Increment Reinvestment Zone propose the following alternate route that is composed of links: 105, 107, 114, 117, 116, 118a, 118c, 352, 170b, 172, 173b, 174, 175, 179, 185. This route has the least harmful impact on City of Pharr communities and commercial areas and respective future growth, both economically and socially. A visual map in PDF form is also attached for your consideration. (See Exhibit "A")
