## JOINT APPLICANTS' NOTICE OF WITHDRAWAL OF OBJECTION TO JUDITH BOSHELL'S REQUEST TO INTERVENE

On August 7, 2013, Electric Transmission Texas, LLC (ETT) and Sharyland Utilities, L.P. (Sharyland) (collectively, Joint Applicants) filed an objection to Judith Boshell's Request to Intervene in this docket based on the information available to them from the Hidalgo County tax records. After additional conversations with Ms. Boshell and her uncle who manages her property, Jimmie Steidinger, Joint Applicants believe that their inability to locate Ms. Boshell's property was due to an error on the Hidalgo County Appraisal District's website, where her property is shown as part of another parcel of land.
