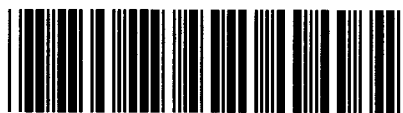

My property is located on the North side of Canton Road between South Cesar Chavez Drive and Raul Longoria Road (Link 142) in Edinburg, Texas.



It is **imperative** that I know when your decision will be made if you intend to go through my property. I have a sell contract for the purchase of my property in the amount of \$200,000. My realtor has notified me by phone that a buyer will wait pending the decision if the power line will go through my property until September 30, 2013.

You are forcing me to potentially lose the sale of my property if you place the power line through it. Are you going to compensate me if I lose my sale?

I am protesting the usage of my property for your power line. I purchased this property in 2001, with the intent to use the proceeds for a retirement fund.


