This letter constitutes our request to intervene in the above captioned proceeding for the Electric Transmission Texas, LLC and Sharyland Utilities L.P.'s request for amendment to their Certificates of Convenience and Necessity and the construction of the North Edinburg to Loma Alta double circuit transmission line, as one or more of the proposed routes would cross or lie adjacent to Hidalgo County Irrigation District No. 1's easements and/or properties, and may interfere with the District's ability to perform its duties and possibly interfere in future expansion of the District's lines, canals or other infrastructure required for the supply of water to cities and farmers.
