transmission line segment 352 cuts through the middle of our property making roughly two-thirds of the land inaccessible and
uninhabitable. Although the land is currently being farmed, there is a subdivision plat recorded under Hidalgo County Clerk's File No. 2005-1559678 for this parcel that illustrates our intentions for the use of the property. The placement of line segment 352 across our
property would be a severe detriment to any future plans/project we might have.
Our family partnership owns an undivided interest in this property and all of the individual landowners are
opposed to having these lines/towers cross through the middle of our tract of land. In a previous rendering, the lines were shown

As one alternative, we would suggest that if the lines are to placed in this area, that they be placed on the north side of us. A second alternative, and one that makes the most sense to us, is to run the transmission lines down the levee, where there are already easements in place and fewer landowners would be affected.
