On June 2, 2014, Sharyland Utilities, L.P. (Sharyland) filed a petition to update its Transmission Cost Recovery Factor (TCRF). On July 2, 2014, Sharyland filed a correction to its petition to correct an error in the initial application identified by Staff. Pursuant to P.U.C. SUBST. R. 25.193(b), a Distribution Service Provider shall update its TCRF twice a year, with effective dates of March 1, and September 1, to reflect changes in the wholesale transmission costs that are billed by Transmission Service Providers to Distribution Service Providers. Sharyland has accordingly requested administrative approval of its petition with an effective date of September 1, 2014.

I have reviewed Sharyland's corrected petition of July 2, and have confirmed that the TCRF calculations reflected in the Company's corrected petition are accurate as filed. I therefore recommend that Sharyland's proposed tariff schedule 6.1.1.6.1 – Rider Transmission Cost Recovery Factor (TCRF), Revision 1, as shown in attachment B of the corrected petition as updated on July 2, 2014, be approved. I further recommend that Sharyland be required to file a "clean" record copy of the approved tariff schedule in Attachment B of the July 2, 2014 petition, 6.1.1.6.1 – Rider TCRF – Transmission Cost Recovery Factor, Revision 1, to be stamped "Approved" by the Commission's Central Records Division and retained for future reference.
