## COMMISSION STAFF'S RECOMMENDATION ON THE TARIFF FILING

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Recommendation on the Tariff Filing and would show the following:

#### I. BACKGROUND

On September 16, 2014, Oncor Electric Delivery Company LLC (Oncor) filed a revised Tariff for Retail Delivery Service in compliance with P.U.C. SUBST. R. 25.214. The filing contained Oncor's existing Retail Delivery Service Tariff revised to comply with the Pro-Forma Retail Delivery Tariff (Tariff) adopted by Commission Order in Project No. 41121 and an annotated version of Chapter 6 detailing changes made to that Chapter. As established in Project No. 41121 the amendments to the Tariff come into effect on January 15, 2015 and therefore Oncor's revised Compliance Tariff must be adopted before then.

Following a review of Oncor's September 16, 2014 filing, Staff informed Oncor of initial changes that would be required in order to assist Staff in completing the final recommendation. On October 16, 2014, Oncor filed a revised clean version of its Compliance Tariff as requested by Staff, incorporating Staff's requested changes. Subsequently on October 22, 2014, Oncor filed revised clean versions of parts of Section 6.1.3.1, Uniform Discretionary Service Charge, and 6.1.4.1, Uniform Discretionary Charges, to correct the amounts charged for new and existing Standard Move-In Charges. The filing also contained a formatting correction in Section 6.1.3.1.

On September 17, 2014 the Commission directed Staff to file a recommendation on Oncor's Compliance Tariff filing by October 31, 2014; therefore, this pleading is timely filed.

#### II. RECOMMENDATION

Based on the attached memoranda of Cliff Crouch of the Commission's Competitive Markets Division, Staff recommends Oncor's Compliance Tariff filed on October 16, 2014, as modified by Oncor's October 22, 2014 filing, be deemed as being in compliance with the



Commission's Final Order and Pro-Forma Retail Delivery Tariff adopted in Docket No. 41121. Staff further recommends that the Commission's Central Records Division substitute the two pages filed by Oncor on October 22, 2104 for the corresponding two pages in Oncor's October 16, 2014 filing and stamp Oncor's October 16, 2014 filing and the two sheets filed by Oncor on October 22, 2014 "Approved" with an effective date of January 15, 2015 and retain the clean record copy for future reference.

#### III. CONCLUSION

Staff recommends that the application be approved and requests an order be issued consistent with this recommendation.

On September 16, 2014, Oncor Electric Delivery Company LLC (Oncor) filed its Compliance Tariff pursuant to Project No. 41121. The filing contained a clean version of the Compliance Tariff and a redline version of Chapter 6 to comply with the Pro-Forma Retail Delivery Tariff (Pro-Forma Tariff) adopted by Commission Order in Project No. 41121 on June 25, 2014.

The Commission directed Commission Staff on September 17, 2014 to file a recommendation on Oncor's Compliance Tariff by October 31, 2014.

Following a review of Oncor's September 16, 2014 filing, Staff informed Oncor of initial changes that would be required to assist Staff in completing the final recommendation. On October 16, 2014, Oncor filed a revised clean version of its Compliance Tariff incorporating Staff's changes.

Oncor's revised Compliance Tariff filed on October 16, 2014 contained the three revisions listed below to the Pro-Forma Retail Delivery Tariff approved in Project No. 41121. Staff agrees that these revisions should be made.

- 1. Section 6.1.4.4 was added to the Table of Contents. This was mistakenly omitted during the adoption of the Pro-Forma Tariff in Project 41121.
- 2. In the second sentence of the third paragraph of subsection 4.8.1.4, "AMS-S" was changed to "AMS-M" as this is the correct reference for this section.
- 3. Company-specific sections that were previously approved by the Commission were incorporated and amended as needed to comply with the Pro-Forma Tariff approved in Project No. 41121.

On October 22, 2014, Oncor filed revised clean versions of parts of sections 6.1.3.1 - *Uniform Discretionary Service Charge* and 6.1.4.1 - *Uniform Discretionary Charges*<sup>1</sup> to correct the amounts charged for new and existing Standard Move-In Charges. The filing also

changed the formatting of Section 6.1.3.1's title to be consistent with the other sections of Oncor's Compliance Tariff.

Following the review of Oncor's filings, Staff recommends that Oncor's Compliance Tariff filed on October 16, 2014, as modified by Oncor's October 22, 2014 filing, be approved as compliant with the Commission's Final Order and Pro-Forma Retail Delivery Tariff approved in Project No. 41121. Staff further recommends that the Commission's Central Records substitute the two pages filed by Oncor on October 22, 2014 for the corresponding two pages in Oncor's October 16, 2014 filing and stamp Oncor's October 16, 2014 filing and the two sheets filed by Oncor on October 22, 2014 "Approved" with an effective date of January 15, 2015 and retain the clean record copy for future reference.
