Enclosed is a copy of a letter from Richard R. Burroughs, Attorney, on behalf of Joe Edward Muirhead. He is requesting to be excluded from the City of Splendora's proposed CCN area for the above referenced application.

We have reviewed Mr. Muirhead's request and find that it meets the criteria in 30 Texas Administrative Code §291.102(h), and is effective without a hearing or other process by the Commission.

Please work with Mr. Muirhead to obtain sufficient information to exclude his property from the proposed service area. Revised maps and digital data, excluding the land mentioned above, should be submitted to the TCEQ within 30 days from the date we forward you the metes and bounds description and survey of his property as written in this letter.

Mr. Muirhead is also requesting a public hearing. Please respond to Mr. Muirhead and forward a copy of the response to this office by **December 18, 2013**. If Mr. Muirhead does not file a written withdrawal of his hearing request, the application will be sent to the State Office of Administrative Hearings for scheduling.
