MOTION TO REMAND

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, the City of Splendora ("City") and files this Motion to Remand the City's Application to Amend Certificate of Convenience and Necessity ("CCN") No. 11727 (the "Application"), and in support would respectfully show as follows:

I. BACKGROUND

The City filed its Application with the Texas Commission on Environmental Quality (the "TCEQ") on April 1, 2013. The Application was found administratively complete on June 28, 2013. On October 4, 2013, the City of Patton Village ("Patton Village") requested a contested case hearing within the applicable period for requesting a public hearing. In a letter dated October 10, 2013, Joe Edward Muirhead ("Muirhead") requested a contested case hearing and to have his property excluded from the CCN area. On September 1, 2014, jurisdiction over the Application transferred from the TCEQ to the Public Utility Commission ("Commission"). Then, on October 6, 2014, Protestants Mark and Stacey Martin (the "Martins") filed a request for contested case hearing. Consequently, the Application was referred to the State Office of Administrative Hearings ("SOAH") for a contested case hearing. After conducting a Prehearing Conference on November 18, 2014 and receiving additional briefs regarding whether the Martins were an "affected person," the Administrative Law Judge issued Order No. 7 on April 15, 2015,
