## STATUS REPORT

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Double Diamond Utilities Co. ("DDU") files this Status Report pursuant to Order No. 6.

## **BACKGROUND**

A preliminary hearing in the above-captioned matter was held on May 8, 2008. In Order Number 1, the ALJ memorialized the preliminary hearing in which she took jurisdiction; designated parties; and established a procedural schedule. On August 13, 2008, DDU and Northwest Grayson County WCID No. 1 (the "District") filed a joint motion to abate this proceeding, and all related deadlines, for sixty (60) days. Thereafter, along with submitting status reports, additional requests for the extension of the abatement period were submitted to SOAH. On December 21, 2008, DDU filed a Status Report and proposed Revised Scheduling Order. The ALJ issued Order No. 5 on January 9, 2009, granting the extension of abatement and continuing the prehearing conference and hearing on the merits until June 21, 2009. The parties were directed to file a status report with the ALJ every 30 days. On June 22, 2009, DDU filed a Motion to Abate Proceedings for an additional six months. On July 23, 2009, the ALJ issued Order No. 6 granting the motion, and abating the matter until December 21, 2009. The ALJ also

requested the submittal of a status report every 30 days. DDU filed a status report on August 21, 2009, September 21, 2009, and October 21, 2009.

#### **STATUS REPORT**

Settlement discussions between the parties are ongoing and DDU remains hopeful that a settlement can be achieved in this matter. In accordance with Order No. 6, DDU will provide another status report within 30 days of this status report.
