ORDER NO. 1
GRANTING MOTION TO CONTINUE PRELIMINARY HEARING

The Chief Clerk of the Texas Commission on Environmental Quality (TCEQ) docketed this case at the State Office of Administrative Hearings (SOAH) on May 30, 2013. On June 7, 2013, the Chief Clerk of the TCEQ issued a Notice of Hearing setting a preliminary hearing on July 9, 2013 at 10:00 a.m.


On June 11, 2013, counsel for the City of Austin filed a motion to continue the preliminary hearing, stating that the scheduled date conflicts with dates specified in a vacation notice letter filed with the Chief Clerk of the TCEQ on May 30, 2013. The motion represents that counsel for Petitioners North Austin Utility District No. 1, Northtown Municipal Utility District, Travis County Water Control and Improvement District No. 10, and Wells Branch Municipal Utility District, as well as counsel for TCEQ, are unopposed to the continuance. In addition, the motion sets forth three agreed dates on which to reset the preliminary hearing.

The motion has merit. The undersigned Administrative Law Judge (ALJ) is assigned to this matter, and is available on one of the agreed dates.

Therefore, it is **ORDERED** that the preliminary hearing in this matter shall commence at **10:00 a.m. on July 31, 2013**, at the William P. Clements Office Building, Fourth Floor, 300 West 15th Street, Austin, Texas.
