NOTICE OF PROPOSED TIMES FOR PREHEARING CONFERENCE**

Equality Community Housing Corporation ("Equality") files this Notice of Proposed Hearing Times for Prehearing Conference and would show as follows.

Pursuant to SOAH Order No. 17, Equality has polled the parties and determined that, with one exception, the parties all agree to propose the following five blocks of time for a telephone prehearing conference on the remaining issue in the case. The only exception to this is that Mr. Wolff has stated that he will not be able to participate in a telephone conference due to his work schedule and asks that the prehearing conference take place without him.


