

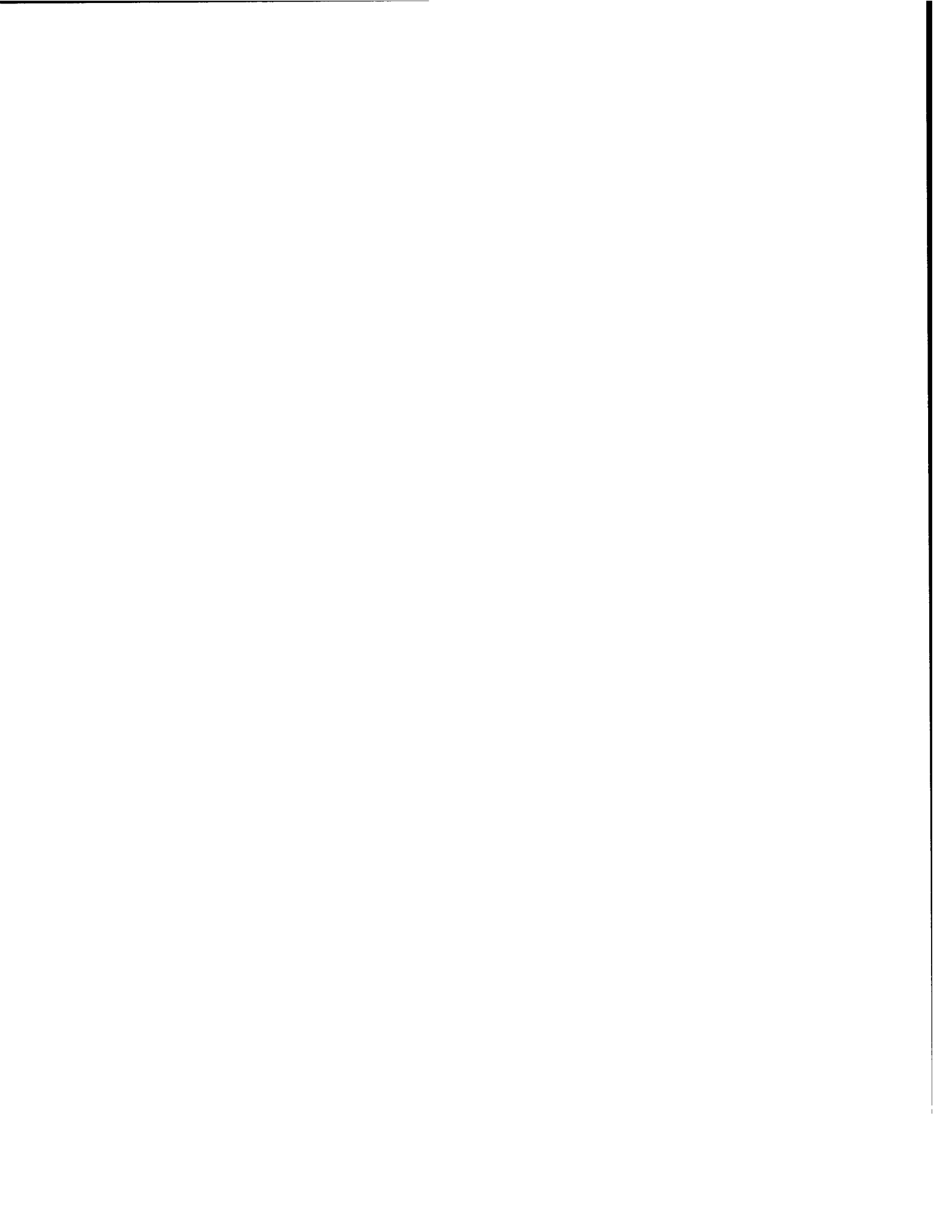



**ORDER NO. 4
ORDER ABATING CASE PENDING REVISED PROCEDURAL SCHEDULE**

On August 20, 2014, the Administrative Law Judge (ALJ) issued Order No. 3, withdrawing the above-reference case from mediation and requiring that the parties provide a status report by September 19, 2014, with three agreed dates for a prehearing conference. On August 22, 2014, Rainbow Housing Assistance Corporation, which is owned by Equality Community Housing Corporation (Equality), filed a Motion for Clarification inquiring whether the procedural schedule will be discussed and revised at the new prehearing conference and abated in the interim. Equality states that if the case is not abated, its pre-filed testimony would be due directly and it needs at least three weeks to prepare. The ALJ finds that schedule should be abated pending the discussion of how this case should proceed at the prehearing conference.

IT IS, THEREFORE, ORDERED that the case is **ABATED** until a revised procedural schedule is entered in this case.
