STATUS REPORT

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Status Report.

On July 29, 2014, a preliminary hearing was held for this matter. Administrative Law Judge Rebecca Smith took jurisdiction and admitted the following as parties to this proceeding: (1) Enchanted Harbor Utility; (2) the Executive Director (ED) of the Texas Commission on Environmental Quality (Commission or TCEQ); and ratepayers Keith L. Smith, Anne Clark, and Evelyn Saucier. On the same day, the parties commenced mediation that lasted throughout the month of August. In the final days of TCEQ's jurisdiction over water utility matters, the parties reached and signed a settlement agreement. On August 27, 2014, Enchanted Harbor Utility filed an uncontested Motion to Remand to the TCEQ with the settlement agreement attached. On September 10, 2014, October 10, 2014, November 7, 2014, December 12, 1014, and January 23, 2015, Staff filed a Status Report with SOAH requesting more time to review the settlement. Staff files this Status Report to request additional time for review.

Pursuant to House Bill 1600 and Senate Bill 567, 83rd Legislature, this matter was transferred to the Public Utility Commission as of September 1, 2014. Because of the procedural complexities involved with the transfer, Staff requests that Your Honor abstain from ruling on the Motion to Remand in order to provide Staff adequate time to review the case and proposed settlement. The utility is currently drafting settlement testimony, which it has promised to provide Staff a draft of by April 8, 2015. Staff endeavors to process the case as quickly as possible; however, in the event no action is taken by May 25, 2015, Staff requests the ability to file a status update or motion to dismiss at that time. Staff has contacted Enchanted Harbor



Utility, Keith Smith, Anne Clark, and Evelyn Saucier. No party has objected, but as of the filing of this Status Report, Staff has not heard back from Mrs. Clark or Mrs. Saucier.
