REQUEST FOR FINALIZATION OF THE SETTLEMENT**

Enchanted Harbor Utility ("Utility") hereby files this Request for Finalization of the Settlement.

As evidenced by the Stipulation and Settlement Agreement attached to the Joint Motion to Admit Evidence and Remand filed by the Staff ("Staff") of the Public Utility Commission ("Commission") on February 28, 2018, the Commission and Utility have fully resolved all issues in this proceeding. On June 11, 2018, the State Office of Administrative Hearings ("SOAH") dismissed the case from the SOAH Docket and remanded the case to the Commission to allow for review of the Stipulation and approval of the Joint Proposed Final Order.

Several months have passed since SOAH remanded the case back to the Commission. The Utility respectfully requests the Commission complete its review of the Stipulation and approve the Joint Proposed Final Order so that this case can be finalized and removed from its docket.
