**ORDER NO. 1
MEMORIALIZING PRELIMINARY HEARING AND ABATING CASE**

On July 29, 2014, a preliminary hearing was convened in this matter. The following appeared and were admitted as parties to this proceeding: (1) Enchanted Harbor Utility; (2) the Executive Director (ED) of the Texas Commission on Environmental Quality (Commission or TCEQ; and ratepayers Keith L. Smith, Anne Clark, and Evelyn Saucier. This order memorializes the matters addressed at that time.

I. JURISDICTION

The ED offered exhibits ED-A, ED-B, and ED-C for the limited purpose of establishing the jurisdiction of the Texas Commission on Environmental Quality and the State Office of Administrative Hearings over the proceedings. The ALJ admitted these exhibits to establish jurisdiction, and found that jurisdiction was properly established.

III. ABATEMENT


Because the Public Utility Commission of Texas will begin regulating water utilities on September 1, 2014, the parties requested that this matter be abated until after that transition has occurred. Accordingly, it is **ORDERED** that this case is hereby **ABATED**. **The parties shall file a status report no later than September 10, 2014.**
