WEST TRAVIS COUNTY PUBLIC UTILITY AGENCY'S REVISED MOTION TO COMPEL TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 12 TO RESPOND TO ITS THIRD REQUESTS FOR INFORMATION

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

The West Travis County Public Utility Agency ("WTCPUA") files this Revised Motion to Compel Travis County Municipal Utility District No. 12 ("TCMUD 12") to Respond to Its Third Requests for Information.

I. REVISED MOTION

On March 5, 2015, WTCPUA propounded its Third Requests for Information ("*RFI*") on TCMUD 12, and on March 30, 2015 TCMUD 12 objected to WTCPUA's RFI No. 3-3 on the bases of relevancy under Texas Rule of Evidence 401, and unduly burdensome. On April 6, 2015, the WTCPUA filed its Motion to Compel ("*Motion*") to request the Administrative Law Judge to deny TCMUD 12's objections and direct TCMUD 12 to respond WTCPUA's discovery request in accordance with the Public Utility Commission's ("*PUC*") procedural rules and the Texas Rules of Civil Procedure.

Subsequent to the filing of the Motion, counsel for WTCPUA and for TCMUD 12 conferred and reached an agreement on limiting the discovery request to certain individuals,
