### Response:

As reflected in SOAH Order Nos. 1 and 2, this proceeding is to determine if the PUA's protested rates charged to TCMUD 12 pursuant to the Wholesale Water Services Agreement adversely affect the public interest. TCMUD 12, as the petitioner, will present evidence that the wholesale water rates that the PUA began charging January 1, 2014 are adverse to the public interest, under at least one of the criteria listed in 30 TAC § 291.133(a). TCMUD 12 has stated the general factual bases for this appeal in its Petition, which is incorporated herein by reference. TCMUD 12 claims that the 2014 rate change evidences the PUA's abuse of monopoly power in its provision of water service to TCMUD 12. The factors that demonstrate the PUA has abused monopoly power include, but are not limited to, the PUA's change in the computation of the revenue requirement or rate from one methodology to another; the PUA's failure to reasonably demonstrate the changed conditions that are the basis for the change in rates (including rate methodology); and the PUA's disparately greater bargaining power, including limitations on

TCMUD 12's alternative means and costs, and problems of obtaining alternative water service. Other factors may be identified based upon discovery responses from the PUA, Bee Cave, Hays County, and/or WTCMUD 5, and this response will be supplemented in accordance with TRCP 193.5.
