PREHEARING CONFERENCE


On December 15, 2014, Staff filed a Motion to Consolidate PUC Docket Nos. 42857 and 42867 into one docket for processing. No party filed an objection. The motion has merit and is granted. The PUC Docket Nos. 42857 and 42867 will be consolidated into PUC Docket No. 42857. After the issuance of this Order, all filings shall reflect only the consolidated docket numbers, SOAH Docket No. 473-14-5138 and PUC Docket No. 42857.

On January 5, 2015, the City filed a Motion for Extension of Time and Prehearing Conference. No party filed an objection. That motion is also granted.

A prehearing conference will be held in this matter beginning at **1:00 p.m., January 14, 2015**, at the State Office of Administrative Hearings, William P. Clements Building, 300 W. 15th Street, Fourth Floor, Austin, Texas. *Individuals who do not have a state-issued identification badge should be prepared to register with a security guard on the first floor of the building. Having the docket number of the case and a photo identification card will expedite the registration. The parties are also advised that finding parking near the Capitol Complex may be extremely difficult when the Legislature is in session.*
