A preliminary hearing has been scheduled for May 14, 2014 at the State Office of Administrative Hearings to discuss the merits of consolidating the Wastewater Case with the Water Case (SOAH Docket No. 582-13-4617). Please reference Order No. 8 issued by Administrative Law Judge Pratibha J. Shenoy in SOAH Docket No. 582-13-4617

We received the appeal of the Petitioners on December 12, 2013. On or about September 10, 2012, the City of Austin's City Council adopted an increase in the sewer rates for its customers including increasing rates for the Petitioners. The first phase of the increased rates went into effect on February 1, 2013.

The Petitioners file this appeal pursuant to Section 13.044(b) of the Texas Water Code ("Water Code") and Title 30, Texas Administrative Code ("TAC") Section 291.45(c). The Petitioners also file this Petition to overturn the rates charged by the City of Austin for wholesale sewer service and for failure to obtain prior approval to increase the rates from the Commission.
