



The area subject to this transaction is located approximately 18.8 miles northwest of downtown El Paso, Texas and is generally bounded on the north by approximately 500 ft. north of Chisom Drive; on the east by the Rio Grande River; on the south by Lisa Drive; and on the Texas/Mexico border.

The total area being requested includes approximately 163 acres and serves 49/58 current customers. This transaction will have the following effect on the current customers' rates and services: Not known at this time.

- state your proposed adjustment to the application or CCN which would (5)

Only those persons who submit a written request to be notified of a hearing will receive notice if a hearing is scheduled. The Executive Director will issue the CCN requested in the referenced application unless a hearing is scheduled to consider the transaction. If no protests or requests for hearing are filed during the comment period, the Executive Director may issue the CCN 30 days after publication of this notice.
