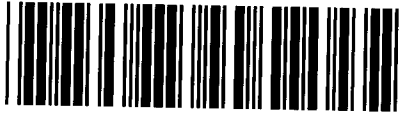

SOAH ORDER NO. 13
REQUIRING ADDITIONAL STATUS REPORT

On May 12, 2016, the Staff of the Public Utility Commission of Texas (PUC) filed a joint status update, advising that the parties were continuing to attempt to finalize a settlement in this case and needed additional time to complete it. Staff asked that the parties be given until June 11, 2016, to file a settlement package or status update. The Administrative Law Judge finds the request to be well-founded, and extends the time further.

THEREFORE, IT IS ORDERED that Staff shall file a status report no later than **June 11, 2016**, if a motion to remand is not filed sooner.
