**COMMISSION STAFF’S REQUEST FOR AN EXTENSION**

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files its Request for an Extension. Staff requests that that the deadline for Staff to file its status update be extended from September 10, 2015 to September 24, 2015. In support of its Request for an Extension, Staff states the following:

**I. Background**

On May 23, 2012, the Brazos River Authority, the Lower Colorado River Authority, and the City of Liberty Hill filed an application with the Texas Commission on Environmental Quality (TCEQ). The applicants requested the approval of the transfer of certain service areas in Williamson County, Texas.

Effective September 1, 2014, the Commission began the economic regulation of water and sewer utilities. This proceeding was transferred to the Commission for processing.

On August 24, 2015, the Administrative Law Judge entered Order No. 1, which established September 10, 2015 as the deadline for Staff to file a status update regarding this proceeding.

**II. Request for an Extension**

The Commission’s procedural rules permit deadlines to be extended upon a showing of good cause.<sup>1</sup> There is good cause in this proceeding because Staff needs additional time to review the files transferred over from the TCEQ in order to determine the status of this proceeding. Thus, Staff requests that that the deadline for Staff to file its status update be extended from September
