LAKESIDE WATER CONTROL AND IMPROVEMENT DISTRICT NO. 1'S RESPONSE TO ORDER NO. 12

COMES NOW Lakeside Water Control and Improvement District No. 1 (the "District"), by and through its undersigned attorneys of record, and files this Response to the Public Utility Commission ("Commission") Administrative Law Judge's ("ALJ") Order No. 12.

On June 7, 2016 Commission Staff filed its Proposed Additional Procedural Schedule and proposed a July 26, 2016 deadline for Staff to provide the District with a final map for consent; an August 5, 2016 deadline for the District to provide Staff with a signed consent form; and an August 19, 2016 deadline for Staff to file a final recommendation. On June 9, 2016, the ALJ issued Order No. 12 – Establishing Deadlines, adopting Staff's Proposed Additional Procedural Schedule.

The District files this response to update the Commission on the status of the events specified in Order No. 12. As of the time of this filing, the District has not yet received the final CCN maps for review and consent. However, the District and Commission Staff have corresponded regarding the status of these final maps, and it is our understanding the final maps are forthcoming. The District appreciates Staff's efforts in preparing these final maps; and in the interest of efficiency, the District does not desire to postpone the final deadline in this matter at

this time. Rather, the District is happy to cooperate with Staff and promptly review the CCN maps upon receipt.
