COMMISSION STAFF'S RECOMMENDATION THAT APPLICATION BE FOUND ADMINISTRATIVELY COMPLETE

Comes now the staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No. 11. In support thereof, Staff shows the following:

I. BACKGROUND

On November 18, 2013, Lakeside Water Control Improvement District 2C and Manville Water Supply Corporation (collectively, Applicants) filed an application for approval of a Contract Service Agreement. The application is being reviewed pursuant to Texas Water Code §§ 13.242-13.250 and 16 Tex. Admin. Code §§ 24.101-24.107.

On April 1, 2016, the Administrative Law Judge issued Order No. 11, which requires Staff to file a recommendation regarding administrative completeness of the amended application and notice along with a proposed procedural schedule, if appropriate, on or before April 19, 2016. Therefore, this pleading is timely filed.

II. STAFF RECOMMENDATION

As detailed in the attached Staff memorandum from Mary Lupo and Tracy Montes, in the Commission's Water Utilities Division, Staff has reviewed the application and finds that Applicants have cured all application and mapping deficiencies. Therefore, Staff recommends the application be deemed administratively complete and Applicants provide notice as outlined in the attached Staff memorandum.

III. PROPOSED PROCEDURAL SCHEDULE

Staff recommends adoption of the following proposed procedural schedule:

IV. CONCLUSION

For the reasons stated above and in the attached Staff memorandum, Staff recommends that the application be deemed administratively complete and requests the adoption of Staff's proposed procedural schedule. Staff further recommends that Applicants provide notice as specifically stated in Staff's memorandum.

¹ Staff is not able to set additional deadlines, such as deadline for Staff to file a final recommendation or request for hearing, until the Applicants file the affidavits of notice specifying when notice was complete.

On November 18, 2013, Lakeside Water Control Improvement District 2C (Lakeside WCID 2C or Applicant) and Manville Water Supply Corporation (Manville WSC) filed a Contract Service Agreement with the Texas Commission on Environmental Quality (TCEQ) pursuant to Texas Water Code (TWC), Section 13.248. On May 22, 2015, Lakeside WCID 2C filed an amended application to obtain water and sewer Certificates of Convenience and Necessity (CCN) in Travis County. The application is being reviewed pursuant to TWC §§ 13.242- 13.250 and 16 Tex. Admin. Code (TAC) §§ 24.101-24.107

Staff recommends that the application be deemed sufficient for filing and that the Applicant issue the attached notices as directed below:

- 2. Provide the correct notice of the application to the following in accordance with 16 TAC §24.106(b) and (c):
 - a) any districts, utilities and cities within (5) miles of the proposed service area;
 - b) any city with an extraterritorial jurisdiction which overlaps the proposed service area;
 - c) county judge of each county;
 - d) any groundwater conservation district that is wholly or partly included in the proposed area;
 - e) landowners with more than 25 acres and any affected parties in the proposed CCN area. The landowner information may be obtained from the county appraisal district tax rolls for the county in which the proposed CCN area lies;
 - f) Publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Travis County.
- 3. Include a copy of a map showing the proposed service areas with the individual notices to neighboring utilities, customers and other affected parties. It is the Applicant's burden to provide an accurate map delineating the proposed service areas with each individual notice. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at http://www14.tceq.texas.gov/iwud/

Within 30 days of the Commission order, the Applicant should file a copy of the actual notice and map issued with the individual mailed notice, tearsheets of the published notice, and the signed affidavits (copies attached), indicating that the publication and notice was given in accordance with 16 TAC § 24.106(b)(6) and § 24.106(c).

Technical Review
The Applicant must submit written documentation from the City of Pflugerville agreeing to decertify a portion of their sewer CCN No. 20678.
