## ORDER NO. 13 ESTABLISHING DEADLINES

This Order addresses Manville Water Supply Corporation and Lakeside Water Control and Improvement District 2C's affidavits of notice, filed on May 20, 2016, along with a copy of the notices sent, and an affidavit verifying publication of notice. According to the affidavits, notice was mailed to neighboring utilities, landowners, and affected parties on April 25, 2016. In addition, notice was published in *The Pflugerville Pflag* on April 27 and May 4, 2016 and in the *Round Rock Leader* on April 28 and May 5, 2016. On June 10, 2016, Commission Staff proposed an additional procedural schedule for continued processing of this application.

A 30 day protest period follows the later of mailed or published notice.<sup>1</sup> In this instance, the 30-day period began on May 5, 2016, and ended on June 6, 2016.<sup>2</sup> No comments, motions to intervene, or requests for a hearing were filed by affected persons. The following schedule shall apply.

Deadline for Staff's recommendation on final disposition	August 26, 2016
