COMMISSION STAFF'S MOTION FOR EXTENSION OF TIME

Comes now the staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this motion for extension of time in response to Order No. 14. In support thereof, Staff would show the following:

I. Motion for extension of time

On August 26, 2016, the Administrative Law Judge (ALJ) issued Order No. 13, which requires Staff to file a recommendation on final disposition by September 23, 2016. Staff will not be able to meet this deadline.

Staff respectfully requests an extension in order to provide Staff sufficient time to create a final map, provide the final map to parties, obtain consent from the parties, and prepare its recommendation on final disposition.

In order to provide for the continued processing of this application as detailed above, Staff proposed the following revised procedural schedule:

Event	Date
Deadline for Commission Staff to provide Applicants with final map for consent ¹	September 30, 2016
Deadline for Applicants to provide Commission Staff signed consent form ²	October 14, 2016
Deadline for Staff's recommendation on final disposition ³	One week after receipt of all consent forms ⁴
Deadline for parties to file joint proposed notice of approval	One week after filing of Staff's recommendation on final disposition ⁵

Staff is authorized to represent that Lakeside WCID 2C does not oppose this request.

II. Conclusion

Staff respectfully requests that the Commission grant Staff's motion for an extension of time and adopt the proposed procedural schedule set out above.


