
Dear Mr. Smith:

The Texas Commission on Environmental Quality (TCEQ) received this petition on March 12, 2012, and accepted it for filing on March 30, 2012. This matter has been referred to the State Office of Administrative Hearings. A date for a preliminary hearing will be scheduled and you will receive notice of the time and place for this hearing.

If jurisdiction is established, you will have an opportunity to attempt to reach an agreed settlement. If settlement is not possible a schedule of dates for discovery, pre-filed testimony, and an evidentiary hearing will be set. We urge you to vigorously pursue local settlement of this matter. In addition, the TCEQ can provide a representative from the Alternative Dispute Resolution Division, available free of charge, to assist you with mediation.
