

We hereby transfer the official file for the above referenced application to the Chief Clerk's Office. Please refer the application to the State Office of Administrative Hearings and request that a hearing be scheduled.

We received protests from Mr. Archie Abrameit, manager of The Stiles Farm Foundation, and from Mr. Leland R. Enochs on behalf of Noack Water Supply Corporation (WSC). The Stiles Farm Foundation currently receives water from Noack WSC and states they are not convinced the City of Thrall is capable of providing a reliable source of water to service their needs. Noack WSC indicates they will be adversely affected by the granting of this application because they would be deprived of potential customers. In addition, Noack WSC indicates the proposed amendment by the City of Thrall overlaps their CCN. The protestants are listed on the attached mailing list. Staff estimates 8 people to attend this hearing.
