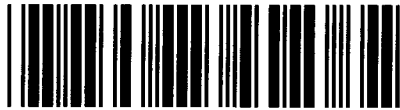

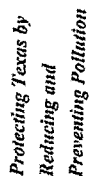

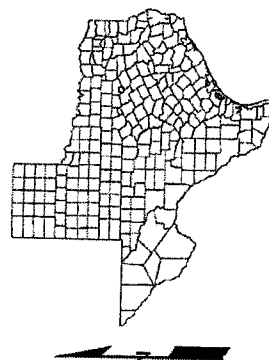

The Selected Area of Interest



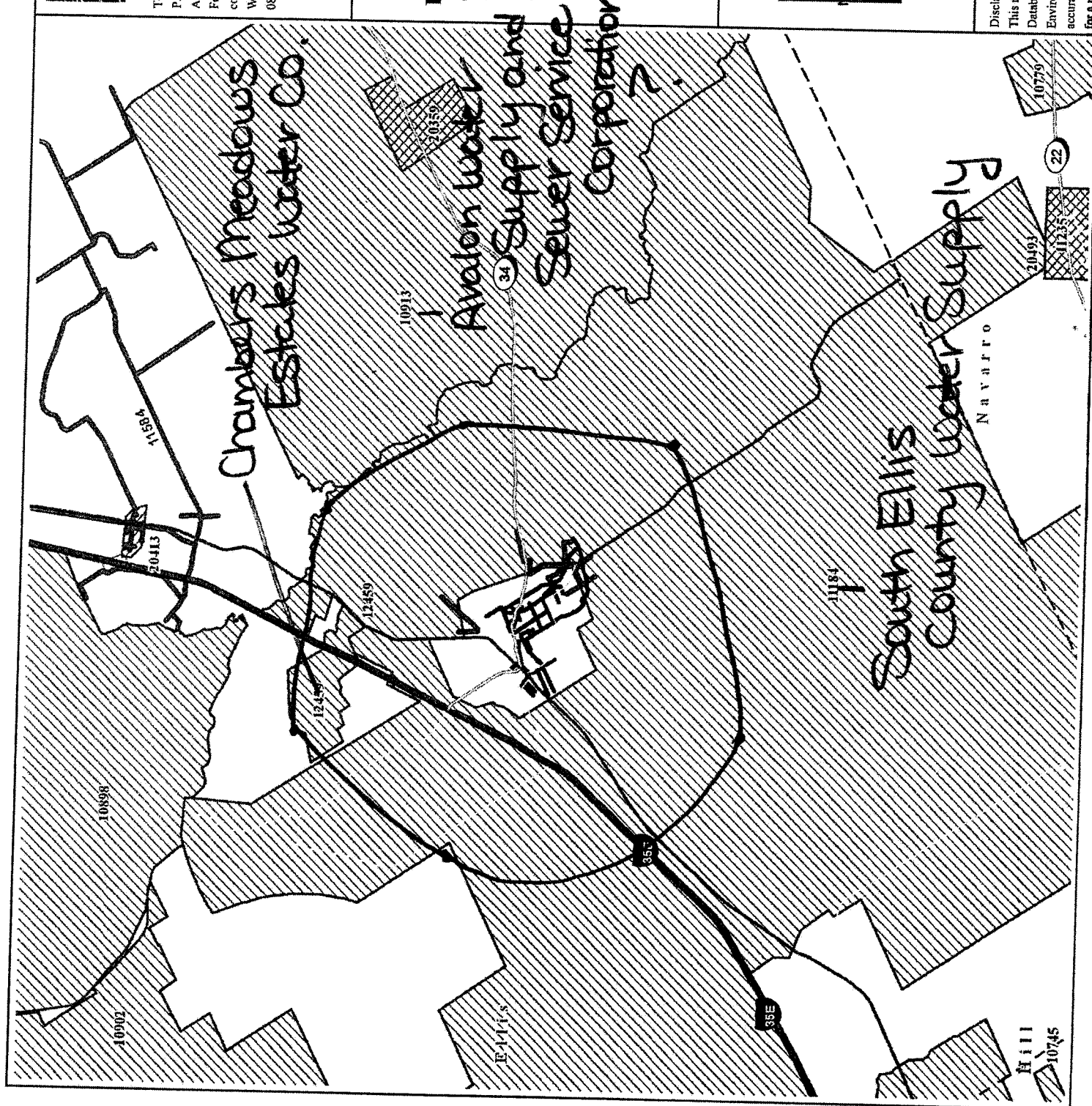

Attached is a map showing that the surrounding utilities within a 2-mile area are:

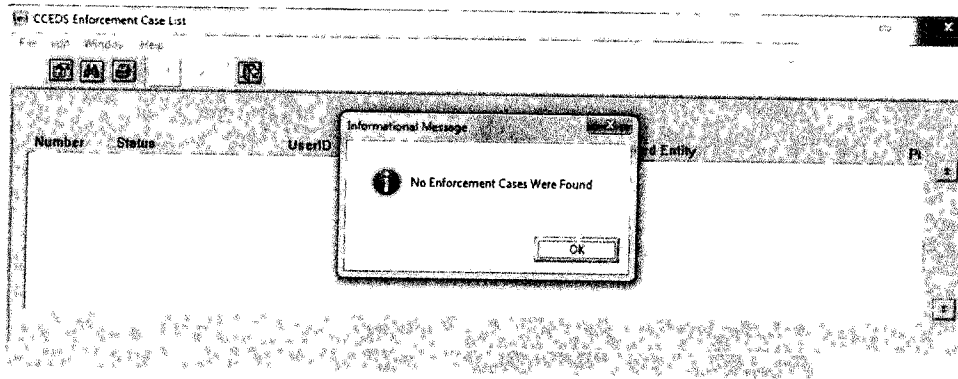
1. Chambers Meadows Estates Water Co.
