## ORDER NO. 11 FOURTH NOTICE FINDING APPLICATION INCOMPLETE AND DEFICIENT

On July 17, 2015, Public Utility Commission of Texas (Commission) Staff filed a supplemental recommendation on the sufficiency of the application of Aqua Utilities, Inc. and Aqua Texas, Inc. d/b/a Aqua Texas (Aqua Texas) for approval of a sale, transfer or merger and to amend certificates of convenience and necessity (CCN) in Chambers, Jefferson and Liberty Counties. Commission Staff recommends that this application is still deficient and not administratively complete as specifically described in the filing and the attached memorandum of Debbie Reyes Tamayo, Program Specialist and Tracy Harbour, GIS Specialist, of the Commission's Water Utilities Division. Pursuant to 16 Tex. Admin. Code § 24.8(a), applications are not considered filed until a determination of administrative completeness is made, thus at this time the application is not considered filed with the Commission.

Applicant should not send out notice to affected parties until these discrepancies are corrected.

Consistent with Commission Staff's recommendation, Aqua Texas' application remains administratively incomplete and deficient. On or before **August 14, 2015**, Applicant shall amend its application to cure the deficiencies noted by Commission Staff. Processing of the application cannot proceed until the requested items are received and reviewed.

On or before August 28, 2015, Commission Staff shall file a supplemental recommendation regarding administrative completeness of the amended application and notice along with a proposed procedural schedule, if appropriate.
