ORDER NO. 14 REQUIRING RESPONSES AND ADOPTING SUPPLEMENTAL PROCEDURAL SCHEDULE

On October 28, 2015, Order No. 13 was issued in this proceeding, establishing a December 2, 2015 deadline for Public Utility Commission of Texas (Commission) Staff to file a recommendation on the transaction proposed in this application or request a hearing. The 120-day deadline for the Commission to act on the transaction is January 28, 2015. On December 2, 2015, Commission Staff requested that Aqua Utilities, Inc. and Aqua Texas, Inc. d/b/a Aqua Texas (collectively, Applicants) be required to address and respond to the multiple Notice of Violation (NOV) letters issued by the Texas Commission on Environmental Quality (TCEQ) relating to certain of Applicants' public water systems (PWSs) before a final recommendation is issued. The NOV letters at issue are discussed in Commission Staff's November 30, 2015 pleading and the attached memorandum of Debbie Reyes Tamayo, Program Specialist, in the Commission's Water Utility Regulation Division, and pertain to 30 Tex. Admin. Code § 290 Subchapters D and F, which governs the drinking water quality and reporting requirements for PWSs in Texas. Commission Staff proposed a supplemental procedural schedule, based on the procedural schedule approved in Order No. 13, for further processing of this application.

Consistent with Commission Staff request, Applicants shall provide documents evidencing responses and resolutions to the NOV letters. The following supplemental procedural schedule will apply for further processing of this application:

Deadline for Applicants to file documents evidencing response and resolution to the NOV letters	December 18, 2015
Deadline for Commission Staff to file a recommendation on the application or request a hearing	December 30, 2015
Expiration of 120-day deadline for Commission action pursuant to 16 Tex. Admin. Code § 24.109(e)	January 28, 2016
