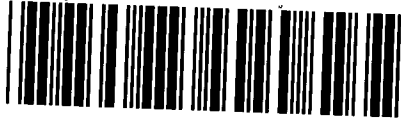

### AQUA TEXAS' STATUS REPORT

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Aqua Utilities, Inc. and Aqua Texas, Inc. ("Aqua Texas") file this Status Report in Response to Order No. 15 and state the following.

#### I. BACKGROUND

On June 4, 2014, Aqua Texas filed an application with the Texas Commission on Environmental Quality (TCEQ) regarding the sale, transfer, or merger (STM) and amendment of Certificate of Convenience and Necessity (CCN) No. 11157 held by Aqua Utilities, Inc. in Chambers, Jefferson, and Liberty Counties, Texas pursuant to TEX. WATER CODE ANN. § 13.301 and Title 16, TEX. ADMIN. CODE (16 TAC) §§ 24.109 and 24.112. Effective September 1, 2014, the Commission began the economic regulation of water and sewer utilities and this case formerly pending at the TCEQ was transferred to the Commission. On January 7, 2016, the ALJ issued Order No. 15 approving the sale and directing Aqua Texas to proceed with the transfer. Pursuant to Order No. 15, the parties were directed to file monthly status updates on the status of the transaction.

## II. STATUS UPDATE

Aqua Texas is diligently working toward completing the transaction, but it has not yet finalized all components needed for same. Thus, the approved transaction is not complete at this time. Pursuant to 16 TAC § 24.112(d) and Order No. 15, Aqua Texas will file proof before January 7, 2017 that the approved transfer was consummated and that customer deposits were addressed after completing the transfer process.
