

## ORDER NO. 11 DEEMING CLOSING DOCUMENTATION SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE FOR CONTINUED PROCESSING

On July 27, 2015, Order No. 7 in the above-styled and numbered docket approved the sale/transfer to proceed. On October 2, 2015, Aqua Utilities, Inc. and Aqua Texas, Inc. d/b/a Aqua Texas (collectively, Applicants) filed closing documents in response to Order No. 10. On October 12, 2015, Public Utility Commission of Texas (Commission) Staff found the closing documentation sufficient to show that the requirements of 16 Tex. Admin. Code § 24.109(g) have been met. Consistent with Commission Staff's recommendation, Applicants' closing documentation is sufficient.

Commission Staff stated they are currently revising mapping information to reflect this transaction and that upon completion, Applicants' consent can proceed. Following that process, Commission Staff will issue a final recommendation regarding this application.

In order to accomplish the preceding process, Commission Staff proposed a procedural schedule for continued processing. The following procedural schedule is adopted:
