Pursuant to Texas Water Code § 13.257, Aqua Texas, Inc., holder of Certificate of Convenience and Necessity No. 13201, hereby files this Boundary Description for the T&A/VLS water systems which are located in McLennan County, Texas.

In accordance with the aforementioned statute, Aqua Texas, Inc. affirmatively states that a portion of its service area included in the aforementioned CCN is as follows:

The water service areas subject to this transaction are located approximately 10 miles northwest of downtown Waco, Texas, and are generally bounded on the north by the intersection of N. Rock Creek Road and FM 2490; on the east by the intersection of McGary Road and Rock Creek Road; on the south by the intersection of Tree Lake Drive and FM 1637; and on the west by intersection of Loyee Lane and Old China Spring Road. The total area being transferred is approximately 207 acres.

The service area is further depicted in the attached PUC certified map.

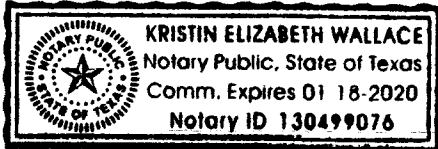

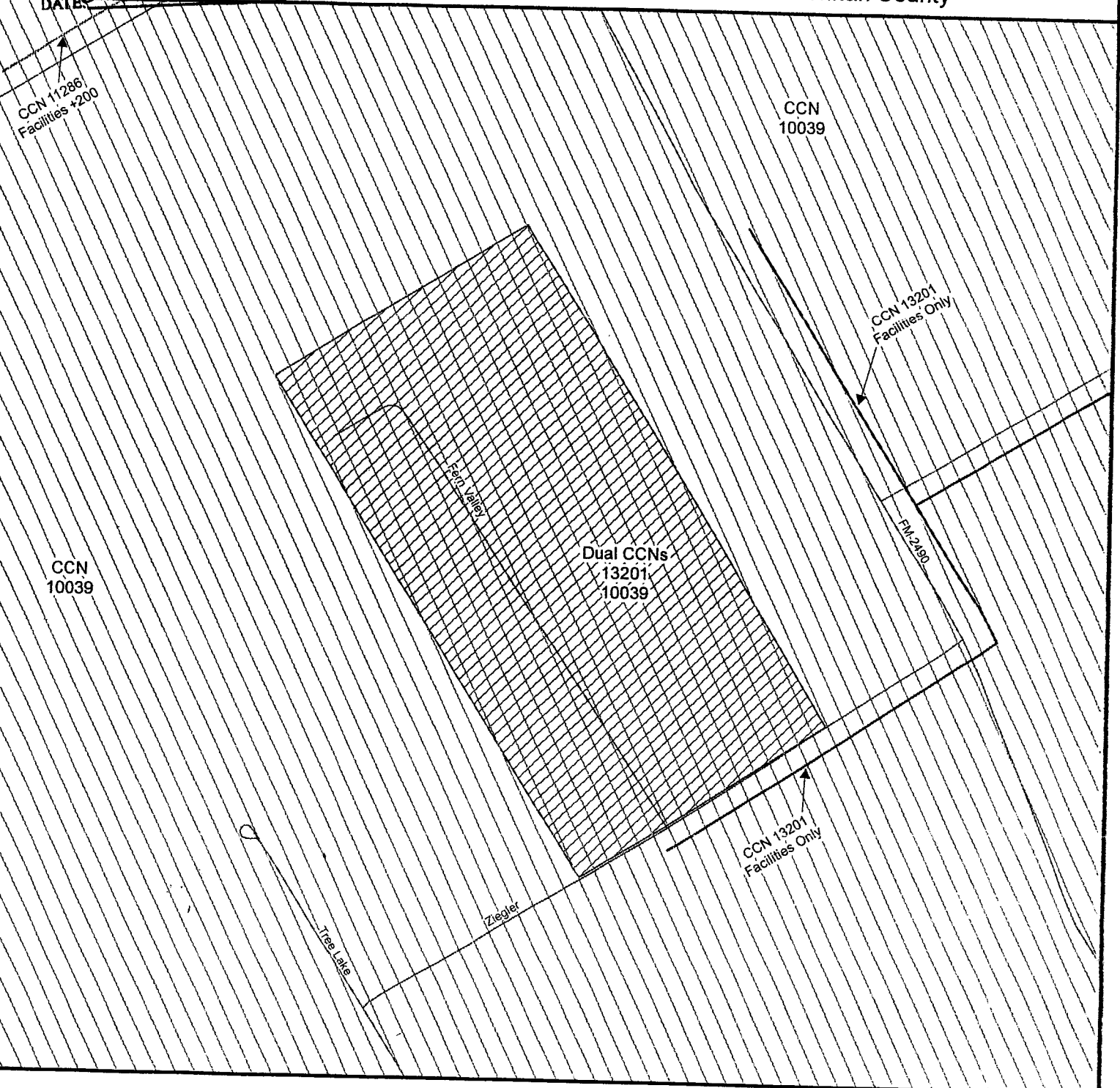
