**SOAH ORDER NO. 5
GRANTING MOTION TO ADMIT EVIDENCE; REMANDING CASE;
AND DISMISSAL OF SOAH DOCKET**

On March 26, 2015, Greenwood Water Corporation (Greenwood), Permian Basin Water Resources, LLC (Permian), and the staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively the Joint Parties) filed a joint motion to approve the Unanimous Stipulation and Settlement Agreement reached between the Joint Parties, admit evidence and approve Greenwood's request pursuant to P.U.C. Proc. R. 22.32. Alternatively, the parties seek dismissal of this proceeding from the docket of the State Office of Administrative Hearings (SOAH) and remand to the Commission for informal disposition under P.U.C. Proc. R. 22.35. The Administrative Law Judge finds merit in and therefore **GRANTS** the Joint Motion.


