

MOTION TO SET ASIDE DIMSISAL AND REOPEN THE RECORD

TO THE HONORABLE JUDGE OF SAID COURT:

Now comes the City of Lyford, and hereby requests the court grant a Motion to Set Aside Dismissal of City of Lyford's Application To Obtain A Water Certificate of Convenience and Necessity in Willacy County and Reopen the Record.

The case had been originally set for hearing on August 6, 2002, but because of a Motion for Continuance filed on the request of North Alamo, it was reset for August 29, 2002.

During the time between the two settings, representative of each entity communicated to each other and reached an agreement concerning Lyford's Application

At the hearing scheduled for August 29, 2002, no representative of the City of Lyford was present due to the understanding that the City of Lyford and North Alamo had entered into an agreement concerning the Application

It is still the belief of the City of Lyford that parties have an agreement concerning the Application. A map of the agreement has been circulated and the parties' representatives have orally approved that map. The only lacking step is final written approval.

WHEREFORE PREMESIS CONSIDERED, City of Lyford asks the Court grant its Motion to Set Aside the Dismussal and Reopen the Record so that an agreement can be tendered to the Court.
