BRIEF IN OPPOSITION TO PROPOSAL FOR DECISION

I. Introduction

The City of Lyford (Lyford) seeks a water certificate of convenience and necessity (CCN) for a portion of Willacy County. In its final application, it is not attempting to ask or require decertification of North Alamo Water Supply Corporation's CCN but rather cocertification in some areas surrounding the City. The Mayor of Lyford and the Manager of North Alamo Water Supply Corporation have signed and filed an Agreement that designates the intended boundary line between areas of service of both parties. The City of Lyford is requesting a decision approving the Agreement and that portion of its Application that is consistent with the Agreement. The Administrative Law Judge proposes that the Commission deny Lyford's Application in its entirety and with prejudice to refilling.

The original application for a water certificate of convenience and necessity (CCN) establishes the need for the CCN for the service of the growing population of the City of Lyford and its surrounding area. The community is a poor community and many of the homes in the area are modest as are the developments that have been proposed. For developers, it is impossible, or at least impractical, to develop in the area since the water distribution mains of North Alamo are miles from the potential area of development. As the developer traditionally pays for the connection between the developer's line and the water main, and the distance to the North Alamo main is great, the sheer cost of connection could actually exceed the cost of development. As a

consequence, developers are discouraged from building and potential homeowners cannot buy. The City mains on the other hand, are close and easily accessible to the areas in question (those areas where developments are most likely). Given the authority, the City could provide the service, the developer could afford to pay for the connection and the resident could purchase. The City could then supply the water and could afford to provide the other services generally provided by a city.

II. BACKGROUND

The initial Application for CCN was filed and set for hearing on July 2, 2002. Counsel for Applicant requested a rescheduling of the hearing and, after several phone calls between his office, the office of the TNRCC and the office of counsel for North Alamo, counsel sent a fax requesting that the hearing be postponed at least until September 13, 2002 so that an agreement could be reached. It was counsel's understanding that this action would result in the postponement.

The ALJ granted the motion to continue and the case was set for August 29, 2002. Prior to that day counsel understood that the parties had agreed on the boundaries, and that specifically the Mayor of Lyford and the Manager of North Alamo Water Supply Corporation had begun making a map that would establish the boundaries of service area between the two entities. The attorney for North Alamo Water Supply Corporation also indicated that he was aware that an agreement was being drawn. Counsel, mistakenly in retrospect, believed that the parties would announce their agreement and file the boundary map at a later time.

The City has filed a motion to reopen the record based on the fact that the parties had reached an agreement. During the following two weeks, maps were drawn and additional discussions took place. On October 11, 2002 an executed agreement was forwarded to counsel for North Alamo and it is understood that it was executed by the mayor's counterpart and filed with the Commission.

The City requests that the record be reopened so that a limited CCN agreed upon and so that residents in the area can have a close and affordable source of water. Without the CCN, development will be prohibitive and growth in the area will be stalled. Exhibit "A" is affidavit of

the City consultant is attached for further explanation. A copy of the signed agreement is also attached as Exhibit "B"

Whereas, thereafter, the parties reached an Agreement resolving their difficulties;






