Re: City of Lyford's Motion to Overturn concerning an Executive Director order dated September 12, 2005, issuing Water Certificate of Convenience and Necessity No. 13035 to the City; SOAH Docket No. 582-02-3005; TCEQ Docket No. 2002-0431-UCR; and Application No. 33790-C.

This letter is in response to a Motion to Overturn filed by the City of Lyford with regard to the issuance by the Executive Director of Water Certificate of Convenience and Necessity No. 13035. In the motion, Richard S. Hoffman, on the behalf of the City of Lyford, states that the City's only disagreement is with the map which differs from the map offered and agreed upon by the parties. After review of the motion, I have determined to extend the time for the Commission to act on the Motion and to request the parties other than the City file responses to the motion and to allow the City to file a reply to any responses. Thus, in accordance with Section 50.139 of the agency's rules, this letter constitutes my order extending the time for the Commission to act on the motion to **5:00 p.m.** on **Friday, December 16, 2005**.

In addition, the Executive Director, the Office of Public Interest Counsel, and the North Alamo Water Supply Corporation may file a response to the motion on or before **5:00 p.m.** on Wednesday, November **2, 2005**. The City may file a reply to any responses on or before **5:00 p.m.** on Wednesday, November **16, 2005**. To be considered timely, an <u>original and eleven copies</u> of any response and reply must be filed in the Office of Chief Clerk by the applicable 5:00 p.m. deadline.
