

This letter is to notify all persons on the attached mailing list that the Texas Commission on Environmental Quality (TCEQ) will consider the above-described Motion and all related filings during its public meeting scheduled to begin at **9:30 a.m. on Wednesday, November 30, 2005**. The Movant, the North Alamo Water Supply Corporation, the Executive Director, and the Office of Public Interest Counsel may each have five minutes to address the Commission on this matter. At this time, the agency has received the responses of the Executive Director and the Office of Public Interest Counsel which recommend granting the Motion and remanding the application to the Executive Director so that a corrected map may be prepared and attached to an order approving the amended application of the City of Lyford.
