#### STATUS UPDATE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Status Update.

# I. BACKGROUND AND DISCUSSION

Corix Utilities (Texas) Inc. filed 17 related sale, transfer, or merger applications with the Texas Commission on Environmental Quality (TCEQ) pursuant to Tex. WATER CODE ANN. § 13.301, which were subsequently consolidated under Docket No. 42867.1 The Commission received the applications between September 15 and September 22, 2014.

In Order No. 3, the Administrative Law Judge (ALJ) consolidated the applications under the above referenced docket number, deemed them administratively complete, found they provided sufficient notice. In a status update filed on January 7, 2014, Staff committed to file a recommendation or status update by January 28, 2015. Therefore, this Status Update is timely filed.

# II. COMMENTS ON APPLICATIONS

Staff continues the process of finalizing the tariffs for the applications.

Docket Nos. 42967, 42968, 42969, 42970, 42971, 42972, 42973, 42976, 42977, 42978, 42979, 42980, 42986, 42987, 43112, 43124, and 43126 were consolidated under one docket number.

#### III. CONCLUSION

Staff continues finalizing the tariffs, and, to the extent that Staff has not made a recommendation on the applications by February 11, 2015, Staff proposes to provide a status update on these applications at that time.
