Re: Claim for damages-sewer backflow

Date of loss: October 3, 2012

Dear Mr. Steffanic:

This will acknowledge receipt of your written notice of claim and request for reimbursement, dated September 10, 2013, for property damages you have claimed at 252 Zimmerman Avenue, Bastrop Texas, which has been received by this office.

Your allegations of damages by sewer lines backing up do not set out or explain how this event may have been caused by any action of the Lower Colorado River Authority (LCRA). However, as I have previously informed you, a gas company contractor notified Corix Utilities and requested that Corix locate the wastewater line, which Corix provided. Even though Corix located the line on the ground, the contractor hit the pipe, causing the back-up of wastewater that you described. Corix Utilities also incurred costs to repair that line as a result of the contractor hitting it, and has filed a claim with them to recover its costs. I understand that Darrin Barker of Corix has previously given this to you, but this is the contact information for the gas company contractor:

I suggest you contact them directly so that you can avoid "going in circles."

Further, the LCRA is a political subdivision of the State of Texas and a "governmental unit" as that term is defined by the Texas Tort Claims Act (Section 101.001, et seq., Texas Civil Practice and Remedies Code) and other statutes. No exception to the LCRA's governmental immunity can be established according to the facts of the incident which you describe. Under applicable law, the LCRA has neither assumed any responsibility nor incurred any liability for any losses or property damages which may have been caused by the circumstances described in your letter.

LCRA is not legally liable for this claim and is immune from liability. Therefore, your claim against LCRA must be denied. If you have any further questions about this matter please feel free to contact me.




