**COMMISSION STAFF'S MOTION TO CONSOLIDATE**

COMES NOW, Staff (Staff) of the Public Utility Commission of Texas (Commission) and files this Staff's Motion to Consolidate.

**I. PROCEDURAL HISTORY**

Corix Utilities (Texas) Inc. (Corix) filed the above referenced sale, transfer, or merger and certificate of convenience and necessity applications with Texas Commission on Environmental Quality (TCEQ) pursuant to TEX. WATER CODE ANN. § 13.301 and § 13.241. The Commission received the applications between September 15 and September 22, 2014.

## **II. MOTION TO CONSOLIDATE**

Staff requests consolidation of Docket Nos. 42967, 42968, 42969, 42970, 42971, 42972, 42973, 42976, 42977, 42978, 42979, 42980, 42986, 42987, 43112, 43124, and 43126 pursuant to P.U.C. SUBST. R. 22.34(a). In order to avoid confusion, staff further requests that the applications be consolidated under a new docket number unique from any of the docket numbers already assigned to the associated applications.

P.U.C. SUBST. R. 22.34(a) states:

Proceedings may be consolidated if the presiding officer finds that: the proceedings involve common questions of law or fact; consolidation would serve the interest of efficiency or prevent unwarranted expense and delay; and, the applicant's ability to present its case and other parties' ability to respond to the applicant's case are not unduly prejudiced. Proceedings shall be consolidated if requested based on the agreement of all parties, and if such consolidation would not unreasonably curtail the time available to process one or more of the proceedings proposed for consolidation.

Staff requests that Docket Nos. 42967, 42968, 42969, 42970, 42971, 42972, 42973, 42976, 42977, 42978, 42979, 42980, 42986, 42987, 43112, 43124, and 43126 be consolidated into one docket for the reason that all the docket numbers stem from the same financial transaction between Corix and the Lower Colorado River Authority (LCRA). The dockets therefore involve common questions of law and fact, and consolidation would serve the interest of efficiency without prejudicing any present or future parties. Additionally, Staff conferred with both Corix and LCRA, and neither party objects to this motion.

## **III. PRAYER FOR RELIEF**

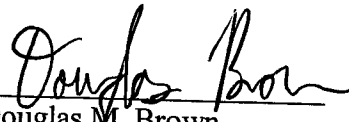

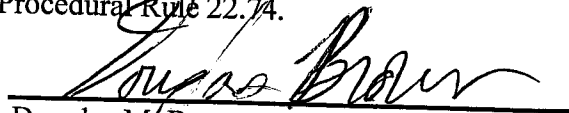
