Also, please provide four (4) copies of the most recent inspection report letter. For each system deficiency listed, if any, attach a brief explanation listing the actions taken or being taken to correct the listed deficiencies, including the proposed completion dates.

Additional financial or technical information may also be requested through future correspondence.

These items must be completed and returned to our office by <u>September 20, 2013</u>.

Processing of this application cannot proceed until the close of the 30 day public comment period which begins after all the required notices have been given. If we do not receive the requested information by this date, your application will be returned for failure to prosecute.

Sunset Water, LLC has filed an application with the Texas Commission on Environmental Quality to purchase facilities from Brinson Inc. dba Sunset Country and to obtain a Certificate of Convenience and Necessity (CCN) to provide water utility service in Moore County, Texas.

The area subject to this transaction is located approximately 6 miles southwest of downtown Dumas, Texas, and is generally bounded on the north by W Rd. R; on the east by Railroad Tracks; on the south by approximately 1 mile south of W Rd. R; and on the west by approximately 1/2.

The total area being requested includes approximately 212 acres and currently serves 47 current customers.

The transaction and the proposed service area include the following subdivision(s) and zip codes: Sunset Country, Sunset Country West, 79029.

A request for a public hearing must be in writing. You must state (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, application number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application or CCN which would satisfy your concerns and cause you to withdraw your request for a hearing.

A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a hearing is scheduled.

If a public hearing is requested, the Executive Director will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or


