ORDER NO. 6

**REQUIRING REVISED NOTICE, GRANTING EXTENSION AND
ESTABLISHING SCHEDULE**

On April 13, 2015, Crystal Clear Water Supply Corporation and the City of San Marcos (collectively, the Applicants) filed a response to Order No. 4 clarifying the transactions, transfers and amendments requested in this proceeding, submitting a signed and dated copy of the agreement of the Applicants, submitting revised notices, agreeing to consolidation of this docket with Docket No. 42984, and requesting an extension of the one-year deadline in P.U.C. SUBST. R. 24.112(e) from June 5, 2015 until July 31, 2015.

On April 14, 2015, Public Utility Commission of Texas (Commission) Staff filed comments stating they do not oppose the Applicants request for extension of the 365-day deadline from June 5, 2015 until July 31, 2015, that they do not recommend consolidating this docket with Docket No. 42984 and recommending that the Applicants be required to provide revised notice and to file proof of revised notice by June 12, 2015. Commission Staff added that on April 17, 2015 they would be filing a supplemental recommendation to include forms for the applicants to use to reissue notice.

On April 17, 2015, Commission Staff filed comments recommending that Applicants be required to provide revised mailed and published notice of the application, and proof of notice by June 12, 2015, using attached forms and affidavits.

Consistent with Commission Staff's recommendation, Applicants' request for an extension of the one-year deadline in P.U.C. SUBST. R. 24.112(e) from June 5, 2015 until July 31, 2015, is granted. Additionally, this docket will not be consolidated with Docket No. 42984.

Finally, the Applicants shall provide revised mailed and published notice and proof of notice, using the forms and according the instructions provided by Commission Staff in its April 17, 2015 filing.

The following procedural schedule shall apply to this proceeding:


Deadline for Applicants to file affidavits of revised mailed and published notice	June 12, 2015
Deadline to intervene, and deadline for intervenors to file comments or request a hearing	30 days after mailing or publication of notice, whichever occurs later
If no request for hearing, deadline for Commission Staff to file a revised proposed notice of approval	July 13, 2015
Extension of the 365 day deadline (from June 5, 2015 to July 31, 2015)	July 31, 2015

Parties are reminded that original and 10 copies of documents relating to this proceeding must be filed with the Commission filing clerk according to P.U.C. PROC. R. 22.71. A copy of each document filed with the Commission must also be served on all parties.

Parties are also reminded that direct communications with the administrative law judges and presiding officer (collectively, ALJs) are prohibited. Questions concerning this Order or any other order must be submitted in writing, filed with the Commission, and served on all parties of record.
